GRAIN DEALER DEFAULT CLAIM WAIVER

5. The producer/producer agent does hereby permanently waive the right to file a default claim under Wis. Stats. § 126.70(1), against said grain dealer.

6. As a producer/producer agent/authorized representative of a producer/producer agent, I submit this waiver, as notification of the ownership interest of at least 50 percent in said producer/producer agent and said grain dealer, and acknowledge that, based on this permanent waiver, grain delivered to said grain dealer is, and will not be, included in said grain dealer's total grain purchases for determination of filing annual financial statements required to be filed with the department under Wis. Stats. § 126.13(1), and determination of assessment payments into the Wisconsin agricultural producer security fund established under Wis. Stats. § 25.463, and that payment for grain delivered by producer/producer agent to said grain dealer will have no right to recovery of claims under Wis. Stats. ch. 126, Subchapter VII.

7. This waiver is to certify facts under which grain is delivered by producer/producer agent to the above named grain dealer and producer/producer agent acknowledges that deliveries of grain from producer/producer agent to said grain dealer cannot participate in the agricultural producer security fund under Wis. Stats. ch. 126, Subchapter III, or in recovery of claims under Wis. Stats. Subchapter VII.

8. The producer/producer agent has authorized the person signing this default claim waiver to execute this waiver. All statements contained in this waiver are true, correct and accurate. The producer/producer agent and the authorized person signing this waiver fully understand that if any statement contained in this waiver is not true, correct or accurate, or is false or misleading, the grain dealer and the authorized person signing this waiver may be in violation of Wis. Stats. § 126.20, and subject to the provisions of Wis. Stats. ch. 126, Subchapter VIII.
