### Dear Wisconsin Children's Safety Advocates:

In July 2019, the U.S. Consumer Product Safety Commission issued a total of **18 recalls relating to products affecting children**. Attached is a summary of the releases identifying the product, the problem, and what should be done with the recalled product.

We have found that not all of the recalls are picked up by the news media as they occur. This monthly summary will give you the opportunity to review all of the children's product safety recalls for the past month. ## **KEEP YOUR KIDS SAFE**

Release Number: (#19-156) Faraday Bicycles Inc., of Santa Cruz, Calif., is announcing the voluntary recall of about 4,450 Faraday electric Porteur, Porteur S, Corland and Cortland S bicycle seat posts. This recall involves seat posts for four Faraday bicycle models, Porteur, Porteur S, Cortland, Cortland S. The words "HL" or "Zoom" are engraved on the seat post. The bikes were sold in various colors including Classic White, British Racing Green, Tungsten, Slate Gray, Midnight Run, Stingray Blue, Seafoam and Coral

**Problem:** The seat post on the bicycles can break, posing a fall hazard to the rider.



This recall involves model year 2013 through 2016 Cannondale CAADX Cyclocross bicycles equipped with disc brakes. Cyclocross racing combines both off-road and on-road cycling. The bicycles were sold in a variety of colors and configurations. Consumers should inspect their bicycle to determine if it is affected by this recall by confirming:

- (1) The bicycle has a prominent CAADX marking on the top tube or other location.
- (2) The bicycle has disc brakes.
- (3) The inside of the fork leg has a large "ULTRAX" marking.
- (4) The cable running to the front disc brake is outside of the fork, as opposed to inside the fork. For assistance determining if a bicycle is affected, consumers should bring it to a Cannondale authorized dealer.

**Problem:** The fork can break, posing a fall hazard with the risk of death and serious injury.

**Problem:** The children's pajama sets fail to meet the flammability standard for children's sleepwear, posing a risk of burn injuries to children.

What to do: Consumers should immediately stop using the recalled pajama tops and contact H&M for a full refund, plus a \$20 gift card.
